Robert E. Grudzinski, 67, beloved husband, father, and grandfather went home to the Lord on Friday.

Robert started his career as an auditor at Lincoln Bank and Chase Manhattan Bank in Syracuse. He graduated from Onondaga Community College with an Associate's Degree in Business and from Syracuse University with a Bachelor's of Science in Accounting. He also worked at PEACE Inc. and later took white collar crime courses at the University of Delaware.

Robert committed his career to fighting financial crime as a forensic accountant for the Onondaga County District Attorney's Office, and retired in 2010 as a Senior Investigator with 28 years of service. In 1996, he was honored with the Jim Stapleton Award for Meritorious Service Above and Beyond the Call of Duty. Robert was also a member of the Association of Certified Fraud Examiners. He was active in the Polish community.
